InPost International Service and InPost International Courier

InPost International	InPost International is a service that allows you to send a parcel in Poland and collect it at delivery points in: France, Netherlands, Luxembourg, Belgium, Italy, Spain, Portugal, Austria, Hungary.
InPost International Courier	InPost International courier is a form of delivery to the Recipient's registered office or place of residence/stay in: Austria, Hungary.

Additional service	InPost International	InPost International Courier
Additional cover	Service available for insured Parcels (within the meaning of the Regulations) containing commercial goods or valuables up to the indicated gross value.	n/d
Shipment to island	Service consisting in the delivery of parcels to collection points located on islands that are the territory of the countries for which the InPost International service is provided. List of islands where delivery is carried out as part of this service: Corsica, Sardinia, Sicily, Majorca, Menorca, Ibiza.	n/d
Pick-up service	Paid courier pick-up - Paid courier pick-up when sending a certain number of parcels (ad-hoc). The service is included in the price if the Sender orders 5 or more parcels to be sent once, and the Parcels sent on the basis of the current Regulations for the provision of Parcel Locker 24/7 service are summed up with courier parcels and elements of freight parcels sent on the basis of the current Regulations for the provision of postal and transport services by InPost Sp. z o.o. and parcels sent as part of the Inpost International website on the basis of the current Regulations for the provision of InPost International services for Business Customers. Service fees do not apply to subscription agreements, unless the provisions of such an Agreement indicate otherwise.	
Non-standard parcel	A non-standard parcel is a parcel with a shape other than a cuboid, including round, cylindrical, or oval, with irregular shapes, or with protruding elements. Hungary, exceeds 110 cm or or has total dimensions (length + width + height) exceeding 210 cm;b. To avoid charges – make sure you correctly declare the size of the parcel when creating the label, and that your parcel does not exceed the maximum weight and dimensions. More details on dimensions, classification of parcels and correct ways of packaging can be found in the document **Guidelines for the preparation and packaging of InPost International parcels** at <https://inpost.pl/regulaminy>.

Parcel verification after changing the size	The fee is charged in the event of sending a Shipment whose actual size is inconsistent with the declared size. When creating a shipment, remember to choose the right size of the parcel with regard to its minimum and maximum height and width.	n/d
Oversized Parcel handling fee	The fee is charged in two cases: a. exceeding the maximum permissible weight for Shipments (12 kg) for Hungary, b. exceeding the maximum permissible weight for Shipments (25 kg) for other countries of delivery, or exceeding any of Size C depending on the country of delivery.	n/d
Verification of the weight and size of the Parcel	n/d	The fee is charged in the event of non-compliance with the real weight or size. To avoid a fee – make sure you provide the exact size and weight of the Shipment.
Oversized Parcels – larger than 500 x 500 x 800 mm or heavier than 30 kg	The fee is charged in two cases: a. exceeding the weight of 30 kg for Shipment, or b. exceeding any of the dimensions of 500 x 500 x 800 mm (height x width x length).	n/d

Non-standard parcel fee	n/d	Fee for a parcel, one of the dimensions of which in the case of the country of delivery: a. The non-standard parcel also includes items with round, cylindrical, or oval shapes, irregular shapes, and/or protruding elements.
Return to Sender	In cases specified in the Regulations, in particular in the absence of a recipient, refusal to accept the parcel or an incorrect address, the Operator will return the Shipment to the sending address. The fee for returning the parcel is equal to 100% (country of delivery: France, the Netherlands, Luxembourg, Belgium, Italy, Spain, Portugal) or 110% (Austria, Hungary) of the net fee paid when sending it (increased by VAT), with the proviso that it will be equal to the net fee for the Shipment according to its actual weight and dimensions determined by the Operator (increased by VAT), in the event of differences between the actual weight and dimensions and those declared by the Customer.	
Contractual penalty	The Operator may impose a contractual penalty on the Sender in the amount specified in this Price List, for violations specified in the Regulations for the provision of InPost International services for Business Customers.

This Price List (treated independently and without an explicit connection with other InPost offers), does not constitute an offer within the meaning of the provisions of the Civil Code.
