

Discount regulations

"Small package at a small price"

1. These Discount Rules "Small package at a small price" (hereinafter: "**Discount Rules**") define the conditions for granting discounts on prices for postal or shipping services provided by **InPost Sp. z o.o.** with headquarters in Kraków at ul. Wielicka 28, 30-552 Kraków, entered into the register of entrepreneurs kept by the District Court for Kraków - Śródmieście, 11th Commercial Division of the National Court Register under the KRS number 0000543759, NIP: 6793108059, REGON: 3607810850 (hereinafter referred to as: "**InPost**" or "**Operator**"), as part of the "InPost Quick Shipments" functionality, available at the following internet address: <https://inpost.pl/SzybkieNadania/>, (hereinafter referred to as the "**Website**") and based on the "Terms and Conditions for the Provision of the "Parcel Lockers 24/7" Service Offered by InPost Sp. z o.o." valid on the day of posting (for Shipments delivered to Parcel Lockers and Parcel Service Points - POP), and the "Terms and conditions for the Provision of Postal and Shipping Services by InPost Sp. z o.o." (for Shipments delivered to an address other than a Parcel Locker or POP, marked on the Website as "Home"), hereinafter referred to as "**Terms and Conditions**".
2. To the extent not regulated in these Rebate Regulations, the Terms and Conditions apply, and all capitalised terms, that are not defined in these Rebate Regulations, have the meaning given to them in the Terms and Conditions; at any given case the provisions of the Terms and Conditions appropriate for a given postal or shipping service apply, depending on the place of delivery of the Shipment specified by the Sender when ordering this service through InPost Quick Shipments.
3. On the basis of these Discounting Regulations, the Operator - for the duration of the discount specified in sec. 10 below - will grant the Senders using InPost Quick Shipments two discounts on the prices of services available on the Website, in accordance with the provisions below.
4. The first discount covers a reduction, for the duration of the discount, of prices for services provided under InPost Quick Shipments on the basis of the Terms and Conditions for the provision of postal and shipping services by InPost Sp. z o.o. ", for Shipments delivered to an address other than a Parcel Locker or POP - which is denoted as "Home" on the Website and is presented as follows:

5. The first discount will be included on the Website for the entire duration of the discount for each Shipment and does not require the Sender to take any additional action or meet any additional conditions.

6. The second discount covers a reduction, for the duration of the discount, of the prices for services provided as part of InPost Quick Shipments on the basis of the Terms and Conditions covering only the Small Package size (pol. "Mała Paczka"), which must also weigh no more than 5.00 (five) kilograms - a Shipment of this weight is referred to as a "Small Package" for the purposes of the Discount Regulations and action and the amount of the discount granted is as follows:

7. The second discount will be applied on the Website during the discount period for each Shipment, if the Sender, at the stage of placing the order on the Website, carries out the following steps in sequence:
- 1) selects the "Small Package" size,
 - 2) in the right part of the Website, in the "Summary" field, select the check-box "I have a discount code",
 - 3) in the field for the rebate code, provide the following code: **lekkapaczka**
8. The correct weight of the Shipment will be verified by the Operator on the terms and in the manner specified in the Terms and Conditions. If the Sender uses the Second discount, but sends a Shipment as a "Small Package" that has a greater weight than that specified for the Small Package in sec. 6 above, the provisions of the Terms and Conditions shall apply; the Operator reserves the right to claim from the Sender an additional payment covering the difference between the discount price and the regular price for a Small Package.
9. The First discount and the Second discount are combined in such a way that the Second discount is applied to the price for the "Small Package" subject to the prior discount under the First discount.
10. The discount period starts on August 18, 2020 and ends on October 31, 2020. The Operator reserves the right to extend or shorten the duration of the discount period by changing the Discount Regulations.
11. These Discount Regulations enter into force on August 18, 2020. The Operator will inform the Senders about changes to the Regulations in the form of information posted on the Website at least 14 days in advance.
